 Fee will be incurred for returned checks.
- Vendors may arrive and set up starting at 9 a.m. CST on Friday, September 4^{th,} 2026, and must leave by Monday, September 7th, 2026.
- Vendors must supply any needed tables, chairs, tents, and POS device. We recommend that vendors bring walls and sidewalls for their booth.
- Placement of vendors is at the sole discretion of Catoosa Music & Adventure Festival.
- All vendors are required to have their space neat and free of hazards.
- Vendors are to refrain from hanging, taping, gluing, stapling, screwing or tacking decorations or other materials onto any venue infrastructure, natural or otherwise.
- Vendor agrees to reimburse Catoosa Event Center/ Catoosa Music & Adventure Festival for any loss or damage occurring to the facility and its contents.
- Set-up and teardown is the sole responsibility of the vendor, including removal of all trash.
- Vendors are required to check-in at Gate and will be issued up to three festival passes. Selling, exchanging, or giving away passes may result in being escorted off festival grounds.
- Each vendor is expected to comply with all local, state, and federal regulations regarding merchandise and sales taxes.
- Insurance: Catoosa Music & Adventure Festival, Catoosa Event Center, Tuckahoe Beach LLC., nor any other sponsors or their affiliates accept liability for vendor goods and services. Vendors concerned about insurance issues are encouraged to pursue individual event insurance coverage.
- Access to a power source is limited. Catoosa Music & Adventure Festival cannot guarantee access to electricity. Small Generators are permitted.
- Vendors are not permitted to sell food or drink items including but not limited to bottled water without prior written approval.
